residents' listing (if they so choose); NR annual events; and many useful numbers of neighboring locations/events. Did you know that if you have an emergency here at North Ranch, response time will be longer if you dial 911? It is recommended to call the Congress Fire Dept. at (928) 427-3100. For nonemergency, call (928) 427-3336.

CAMA needed a new Sunshine person, and Chris Wood will be doing this in the future.

We are still in need of Kitchen Supervisors—this is not a one-person only job. We need at least two, and better, would be three. There must be a supervisor whenever the kitchen is open—for busy bakers, breakfasts, ice cream socials when we dip the ice cream, holiday dinners. The kitchen supervisor must take a county class in Prescott, cost \$100, for a certificate. We have people who have taken a food handler's class for helping in the kitchen, but they are not kitchen supervisors

Other: None.

Unfinished business: None.

New business: None.

Public Comments: Question about Chapter 32—what? where? when? All questions were answered.

Another question re the lighted candles on Hwy 89, outside park, where accident occurred resulting in a fatality. Resident thought this could be a fire hazard. Recommended that she call the Congress Fire Dept. non-emergency number to report.

Questions re lot sitters and more than two persons per lot; guests staying more than 21 days. This could be damaging to a septic system set up for no more than two people on a lot and water usage. Discussion followed. Recommended that if one sees a problem, talk to the individual(s), letting them know that the CCR's are not being followed. If no compliance, then Advisory Committee can write a letter to RPI. We have not been very successful in that area. The county Assessor's office may be able to offer some guidance if this is a direct violation of county requirements.

Residents had questions about why the Activity Center cannot be opened for activities; it needs to be up and running again. Kitchen cannot be opened until we have a Kitchen Supervisor. RPI is still requiring masks to be worn for inside activities. RPI must approve before Activity Center can be opened. Discussion followed—some suggestions were to have residents write letter/ petition to RPI, or a letter from Advisory Committee to RPI.
